ANNUAL REPORT

For the period 1/1/12 through 12/31/12

1. The Palm Beach County Pretrial Services Program (PTS) whose administrative offices are located at 3228 Gun Club Road, Room S-108, West Palm Beach, FL 33406, consists of a staff of twenty-two (22) individuals and is funded by the Palm Beach County Board of County Commissioners. Funding for calendar year 2012 is \$1,226,038.
2. The \$1,226,038 comprises the operating budget of the program (no capital budget) which is funded by county ad valorem dollars and user fees. The funds go to a) providing verified information to the Court for arrested individuals appearing in 1st Appearance Court, so that informed decisions regarding bond may be made, and b) supervising the court's release conditions of those clients released to program supervision by the Court, and c) providing county community service program administration.
3. The amount of fees paid by defendants to the pretrial services program was \$172,746 for the reporting period.
4. The number of defendants assessed was 24,455 and the number interviewed was 15,227.
5. The Pretrial Services Program neither recommends for nor against pretrial release. The decision is solely at the discretion of the Judicial Officer.
6. The number of defendants who were declared indigent at First Appearance Court was 14,369 for those assessed and 11,574 for those interviewed.
7. Of the 3,237 defendants released on Supervised O.R. 79 individuals (2%) failed to attend a scheduled court appearance and were issued Failure to Appear Warrants. (Attachment #1 shows the names of the individuals as well as the date upon which they were terminated. Weekly register reports are filed with the Clerk of Courts at <http://www.mypalmbeachclerk.com/pretrial-release-register.aspx>).
8. Of the 3,237 defendants released on Supervised O.R. 225 individuals (7%) were rearrested. (Attachment #2).
9. The net daily cost of operation for the Palm Beach County Pretrial Services Program for the reporting period was \$4.49 per client per day. The daily cost to house an inmate in the Palm Beach County Jail is reported at \$123 per inmate per day.

The Palm Beach County Pretrial Services Program (PTS) *Intake Unit* provides verified information to the First Appearance Court Judge 365 days per year so that informed decisions may be made regarding bond for defendants appearing in that court. The PTS *Supervision Unit* (SOR) provides court sanctioned supervision for an average of 650 total individuals pending the disposition of their cases in Court

Intake services are delivered at the Palm Beach County Jail on Gun Club Road as well as the Belle Glade Courthouse. *Supervision* services are offered at the Main Courthouse, North County Courthouse, South County Courthouse and Belle Glade Courthouse.

All PTS services are directly related to cost savings for Palm Beach County taxpayers. Intake staff efforts of interviewing, verification and court presentation result in *Supervision* staff carrying an average daily caseload of 600 out-of-custody individuals who may otherwise be incarcerated in the County Jail at the cost of \$123 per day, thus offering a substantial jail housing cost avoidance to taxpayers.
