**ORDER ON DEFENDANT'S MOTION TO AMEND PRETRIAL
RELEASE CONDITIONS**


The above-styled cause came before the Court on February 28, 2014 on the Defendant's Motion to Amend his Pretrial Release Conditions. The Court having heard argument of both the State and Defense, and over objection of the State, hereby orders that the Defendant's pretrial release conditions are amended only as to the following, with all other pretrial release conditions previously ordered to remain in full force and effect:

1. The Defendant shall be permitted outside of his residence, i.e., within 300 yards of said residence, for up to three (3) hours per day;
2. That pursuant to the present trial schedule, the Defendant shall be escorted by Palm Beach County Sheriff's Office to his lawyers' offices if requested seven (7) days per week from 8:00 a.m. to 5:00 p.m., from the date of this Order up until the time the trial commences, March 17, 2014, with proper notice given to PBSO by the Defendant;
3. That during the trial, scheduled to begin March 24, 2014, the Defendant shall

be escorted by PBSO to his lawyers' offices to arrive at said offices by 7:00 a.m. each trial day. Additionally, at the end of each trial day, the Defendant shall be permitted to return to his lawyers' offices and remain there until 7:00 p.m., whereupon PBSO will then escort the Defendant back to his residence.

4. That conditions detailed in paragraphs 3 and 4 apply to the present trial schedule. Should the trial dates change, then paragraphs 3 and 4 are null and void, and with the exception of paragraph 1, all original release conditions remain in effect.
